Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to DMMP Ltd via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;			
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and /or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);			
Data Protection Laws	any applicable law relating to the processing of personal Data, including but not limited to the GDPR, and any national implementing and supplementary laws, regulations and secondary legislation;

- 2. In this privacy policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

- 3. This privacy policy applies only to the actions of DMMP Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

How we collect Data

- 6. We collect Data in the following ways:
 - **a.** data is given to us by you;
 - **b.** data is received from other sources; and
 - **c.** data is collected automatically.

Data that is given to us by you

- 7. DMMP Ltd will collect your Data in a number of ways, for example:
 - **a.** when you contact us through the Website, by telephone, post, e-mail or through any other means;

 - c. when you complete surveys that we use for research purposes (although you are not obliged to respond to them);

 - f. Payment processors.

Data that is received from publicly available third parties sources

- 9. We will receive Data about you from the following publicly available third party sources:
 - a. Public databases or registers;
 - b. Online directories or phonebooks;
 - c. Social media platforms and professional networking sites;
 - d. Search engines;
 - e. News articles, press releases, and media outlets;
 - f. Public event attendees or conference directories.

Data that is collected automatically

- 10. To the extent that you access the Website, we will collect your Data automatically, for example:
 - a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.

Our use of Data

Keeping Data secure

- 17. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a user name that is unique to you.
 - b. we store your Data on secure servers.
 - c. payment details are encrypted using SSL technology (typically you will see a lock icon or green address bar (or both) in your browser when we use this technology.

- 19. Data retention

Your rights

- 22. You have the following rights in relation to your Data:
